

**INFORMATION SHEET FOR  
POTENTIAL FRANCHISEES / INVESTORS / REAL ESTATE OWNERS/ BROKERS**

The company "GREGORYS S.A.", seated in the Municipality of Alimos, 8 Archeou Theatrou St., GR: 174 56, (hereinafter the "Company", "we" or "us"), as the controller of your personal data, takes all necessary measures to protect data from unauthorized access, loss, misuse and theft, pursuant to the provisions of the General Data Protection Regulation (GDPR 2016/679), the currently applicable Greek Legislation and the decisions of the Hellenic Data Protection Authority (HDPa).

The following information will help you better understand what data we collect and how we manage the information after we collect it, how we manage the information in relation to third parties and what are your options as regards the way we use that information.

If you send information regarding your interest in a GREGORYS store or information that will be collected in a subsequent communication or meeting between us, we notify you of the following:

Personal data is defined as any combination of data elements that identify an individual and provide specific information about them, their circumstances, etc. The data collected and processed by the company are the following:

- Personal information, e.g. name, contact details (email, contact numbers)
- Any other information that may be relevant to the candidate, e.g. area of interest, proposed real estate (address), available funds, etc.

Your data may be held in digital and/or paper form.

**Purpose- Legal basis:**

(a) during the pre-contractual stage and especially in the case of filling out an online application form (for a franchise or for the submission of a real estate), the purpose is to investigate the possibility of investment or cooperation in the development of our network; the legal basis of the above is executing the contract and serving of the Company's legitimate interest to pursue its purposes (seeking investors and partners for the further development of the branch network) by responding to the requested communication to investigate the possibility of doing business with you.

(b) In the event that a transaction is made with the Company, after you have signed a relevant contract, the data that you have provided to us - by submitting the request - will be processed with

a view to implementing/executing our contract. In this case the legal basis of the processing is the execution of our contract as well as compliance with the laws [article 6 (1) (b) and (c) of the General Data Protection Regulation].

### **Data retention and transfer**

The Company retains personal data solely for the aforementioned purposes mentioned and archives it for documentation reasons. Your personal data recipients are in principle the individuals who work with the Company and are authorized to fulfil the aforementioned purposes. In addition, as part of this processing and in the case we cooperate, the Company will deploy the services of third parties, to whom your personal data will be disclosed and who will process it on behalf of the Company, as part of the performance of our contractual covenants. In particular, your data will be disclosed to IT service providers, legal entities as well as other natural or legal persons with whom we cooperate or may cooperate directly or indirectly for these purposes. By way of exception, the Company will disclose your personal data to third parties (other than those mentioned above), such as to competent police authorities, prosecutor offices and in general public authorities and State bodies, only in case of a relevant statutory obligation or if so obliged pursuant to a decision, order, subpoena or investigation by a court and/or prosecutor or similar process. We do not share the information you have provided us with unaffiliated or other third parties. When you provide the Company with personal data, we take actions to ensure that your data is managed securely. Unfortunately, no data transfer over the Internet is guaranteed to be 100% secure. This means that our Company uses its best endeavours to protect your personal data, however we cannot ensure or guarantee the security of the data you transmit to us and you do so at your own risk.

### **Rights of the data subject:**

You may exercise the right of access to the personal data we maintain for you at any time. You can contact us by phone (210 9971100) or by e-mail (dpo@gregorys.gr) or by visiting the Company (8 Archeou Theatrou St., Alimos Attica) to request clarifications and further information regarding the collection and processing of your personal data. You may request the amendment of your personal information at any time. You may exercise the "right to be forgotten" and request that your personal data be erased whenever you consider this fit. You have the right to object, restrict processing or withdraw your previous consents (in case of actions that require prior consent according to law) if the legal requirements are met and to inform the Company about your withdrawal.
